	1.2	Throughout this Bidding Document :	
		a.	The term “in writing” means communicated in written form with proof of receipt;
		b.	If the context so requires, singular means plural and vice versa; and
2. Source of Funds	2.1	c.	“Day” means calendar day.
		GoN Funded: In accordance with its annual program and budget, approved by the GoN, the Purchaser intends to apply a portion of the allocated budget to eligible payments under the contract(s) indicated in the BDS for which this Bidding Document is issued.	
	2.2	OR, DP Funded: The GoN has applied for or received financing (herein after called “funds”) from the Development Partner (hereinafter called “the DP”) indicated in the BDS toward the cost of the project named in the BDS. The GoN intends to apply a portion of the funds to eligible payments under the contract(s) for which this Bidding Document is issued.	
3. Fraud and Corruption	3.1	DP Funded: Payment by the DP will be made only at the request of the GoN and upon approval by the DP in accordance with the terms and conditions of the financing agreement between the GoN and the DP (hereinafter called the “Loan Agreement”), and will be subject in all respects to the terms and conditions of that Loan Agreement. No party other than the GoN shall derive any rights from the Loan Agreement or have any claim to the funds.

	7.3	The Bidder is expected to examine all instructions, forms, terms, and specifications in the Bidding Document as well as in Amendments, if any. Failure to furnish all information or documentation required by the Bidding Document may result in the rejection of the Bid.
	7.4	The Invitation for Bids issued by the Purchaser is not part of the Bidding Document
8. Clarification of Bidding Document / Pre-bid Meeting	8.1	A prospective Bidder requiring any clarification of the Bidding Document shall contact the Purchaser in writing at the Purchaser's address indicated in the BDS.
